Background	Following the violence which started on 25 August 2017, in the Rakhine state of Myanmar, thousands of Rohingya ethnic people were displaced internally and some across the border into neighbouring countries.			
	The Rohingya Refugee camps, like most other refugee camps, suffer from overcrowding, food insecurity, poor household economies and environmental risks owing to annual monsoon rains and cyclones. After the first positive COVID-19 case was confirmed in the Rohingya Refugee camps in May 2020, the crowded camp conditions became a concern for both the Rohingya Refugees, and humanitarian community and continue to remain so. Gender-Based Violence remains a serious protection concern for Rohingya refugee women and girls, according to incident reports, physical, and sexual violence, emotional abuse, denial of resources, and forced marriage are among the primary forms of violence frequently reported. (GBVIMS, 2020).			
	The Rohingya GBV in Emergencies (GBViE) program focuses on response, prevention, risk mitigation, and community engagement initiatives to end all forms of violence against women and girls, boys, and men. As part of its global mandate to address gender inequalities and fundamental rights challenges, the United Nations sexual and reproductive health agency, UNFPA, leads GBV specialised and non-specialized partners to achieve three transformative results- end maternal death, end unmet needs for family planning, and end gender- based violence and all harmful practices. (UNFPA, 2020).			
	Within this context, UNFPA with support from the World Bank (WB) initiated a 30-month project (2020-2022) entitled, Addressing Gender and Social Inclusiveness and Preventing Gender Based Violence through the Emergency Multi-Sector Rohingya Crisis Response Project (EMCRP). An agreement was signed to this effect on November 12th 2019. The EMCRP will focus on improving the socioeconomic condition & disaster resilience through the improvement of basic facilities and community services in the affected area for the refugee population, referred to as the Forcefully Displaced Myanmar Nationals (FDMN), by the Bangladeshi government. The project will also promote medium-term recovery and development of the Rohingya population by building on the on-going humanitarian assistance and disaster relief operations being implemented by UNFPA.			
Purpose of consultancy:	The Overall objectives of the Impact Evaluation of Emergency Multi-Sector Rohingya Crisis Response Project (12 Nov 2019-5 March 2023) are to (i) help assess the relevance, efficiency, effectiveness, and sustainability of the project. (ii) broaden the evidence base for the design of succeeding initiatives to prevent and respond to GBV highlighting the progress and change against project output from a dynamic perspective iii) measure the individual, community and institutional level impact of EMCRP on Women, Men, Girls and Boys.			
	Emergency Multi-Sector Rohingya Crisis Response Project strengthens the Government of Bangladesh systems to improve access to basic services and build disaster and social resilience of the displaced Rohingya population.			

Objective and Key Deliverables of EMCRP:

The project provides GBV prevention and response and integrated SRHR services to women and men living in camps and immediate host communities focusing on young people, both boys, and girls, to empower them and improve their skills. Specifically, the project has three key

deliverables:

- i) Situational analysis and development of a strategy for GBV prevention,
 ii) GBV response and prevention capacity building and service delivery
- **iii)** The deployment of A&Y programming for host and FDMN/DRP communities in appropriate spaces, including multi-purpose child and adolescent-friendly spaces and cyclone shelters (based on availability).

The specific objectives of EMCRP Impact evaluation are as follows:

- Provide an independent assessment of the **relevance**, **effectiveness**, **efficiency** and **sustainability** of UNFPA and its implementing partners in achieving the expected outputs and outcomes set forth in the Emergency Multi-Sector Rohingya Crisis Response Project.
- Draw key lessons from the implementation of the Emergency Multi-Sector Rohingya Crisis Response Project and provide a set of clear and forward-looking options leading to strategic and actionable evidence-based recommendations for future GBV programme designing for any succeeding initiatives.
- Assess the result and M&E framework, pros/cons of approaches and strategy used
 the project.

Scope of work:

(Description of services, activities, or outputs)

Under the overall supervision of GBV in Emergency Team leader, the international consultant will lead the ECRMP IMPACT Evaluation process, methodology development, data analysis, and report.

Under the overall guidance of the GBV Program Specialist, a EMCRP Impact Evaluation I National Consultant will be hired to work directly with the EMCRP Impact Evaluation International Consultant.

The Consultant will work with the international consultant and conduct the following tasks: information gathering with local stakeholders, interviews, focus group discussions, interpretation, translation, and data collection. The Consultant will work in close collaboration and coordination with the GBVIE UNFPA team to align with best practices in terms of data collection and information management, to obtain introductions to partners and key informants, and to ensure the "do no harm" approach as part of the study.

More specifically, the consultant will fulfil the following purposes:

- Analyse the achievement of the project against expected results at the output and outcome levels under the EMCRP from November 2019 to March 2023.
- Carry out field visits and meetings with key informants.
- Collect & analyse quantitative and qualitative data from diverse stakeholders in line with the approved project Results Frameworks & the project M&E framework; Document quantitative and quantitative results against all project indicators.
- In addition to the indicator results, gather and consolidate additional data and information (qualitative and quantitative) to provide evidence of project accomplishments within each activity area and address all agreed upon evaluation on questions

- Document the facilitating and constraining factors for the EMCRP, as well as lessons learned; and
- Produce the IMPACT report of the EMCRP project , including recommendations for any future activities and adjustments to current initiatives
- Assess differences in implementing partner effectiveness and their most significant contributing factors
- Based on the evidence and analysis, draw conclusions about the project's overall achievements, lessons and contribution to the protection impact. Prepare a comprehensive report with a set of implementable recommendations for immediate & medium term goals as well as future direction.

The specific responsibilities of the national consultant are as follows:

- Support the overall evaluation process in close coordination with UNFPA and IPs GBV in emergency experts;
- Support the development of the methodology, the tools for data collection and reporting templates and get them endorsed by UNFPA.
- Support the data collection process (both primary and secondary)- and its analysis.
- Draft the initial report and share it with the UNFPA team and IPs for validation. Present the key findings to UNFPA Cox's Bazar sub-office and relevant stakeholders during an in-country stakeholder validation workshop, and incorporate feedback received into the final report.
- Submit the final report to UNFPA.

- Is there synergy between the project interventions and interventions by other humanitarian partners? Or, do the project interventions complement projects by other humanitarian partners?

Efficiency
